#### **Notes**

- 1. Electricity Line Losses:** The delivery charge also includes costs relating to electricity lost through distributing electricity to your home.
- 2. Smart Metering Entity Charge Rate Rider** - This rate rider is to recover the Independent Electricity System Operator's costs of developing and implementing the Meter Data Management Repository (MDM/R) and its information technology to collect and process data from smart meters throughout the province. The Smart Metering Entity Charge is distinct from the costs that distribution companies such as Kingston Hydro recover through the delivery charge for their smart meter and system costs related to the initiative.
- 3. Adjusted Usage:** The kWh usage used to calculate Retail Transmission Charges, and Regulatory Charges are kWh adjusted for loss factor. Kingston Hydro loss factor for this rate class is 1.0393.
- 4. Global Adjustment (GA):** Customers signed with a retailer and those on hourly Ontario electricity pricing (HOEP) see the separate GA charge. This is set by the [Independent Electricity System Operator \(IESO\)](#).
- 5. Global Adjustment (GA) Modifier:** Under the Ontario Fair Hydro Plan Regulation, the OEB sets an amount – the GA Modifier – that electricity distributors and others will apply to reduce the GA payable by eligible customers on electricity consumed between July 1, 2017 and April 30, 2018.
